### Biography

Mehmet OKYAYUZ (Göç Araştırmaları ağırlıklı kısa BİÖ)

Almanya’da büyümüş olup Ocak 1995’te Türkiye’ye kesin dönüş yaptım. O zamandan beri Orta Doğu Teknik Üniversitesi / Siyaset Bilimi ve Kamu Yönetimi Bölümü’nde öğretim üyesi olarak çalışmaktayım. Paris/Fransa ve Almanya’nın Berlin, Heidelberg ve Marburg üniversitelerinde Siyaset Bilimi, Sosyoloji ve Felsefe eğitimi aldıktan sonra, Ruprecht-Karls-Universität Heidelberg’den Master, Philipps-Universität Marburg’dan ise doktora derecemi aldım. Sözlü ve yazılı olarak ana dilim gibi Almanca, çok iyi derecede İngilizce, iyi derecede Fransızca ve metin okuyabilecek düzeyde Latince bilmekteyim.

Temel eğitim ve araştırma alanlarım; Siyasi Teori/Düşünce, Siyaset Analizi, Karşılaştırmalı Siyaset ve Göç Hareketleri/Göç Politikalarıdır. Diğer alanlarda yazdığım metinlerin yanısıra göç alanına ilişkin birçok makalem, editörlük yaptığım bir kitap, yazdığım birçok kitap bölümü ve orijinali Almanca olarak çıkan ve daha sonra ülkemizde de yayınlanan bir kitabım [*Federal Almanya’nın Yabancılar Politikası*] bulunmaktadır.

Ağustos 2008 ile 2012 yılları arasında YÖK tarafından oluşturulan İstanbul Türk-Alman Üniversitesi Çalışma Grubu üyesiydim. Farklı alanlardan gelen üniversite hocalarından oluşan bu grup halen faaliyet gösteren üniversitenin idari ve akademik örgütlenmesinin temellerini atmıştır.

Bu dar anlamda akademik faaliyetlerime ek olarak 2016-2017 yıllarında daha sonra Hacı Bayram Veli Üniversitesi bünyesine katılan Türkiye ve Ortadoğu Amme İdaresi Enstitüsü’nde (TODAİE) *Göç Kuramları* başlıklı yüksek lisans dersi verdim. Akşam verilen bu ders, TODAİE’nin Üniversite – Kamu işbirliği geliştirmeye ‘misyona’ uygun olarak (Göç İdaresi gibi) çeşitli kamu kurumlarında çalışan kişilerin göç alanında uzmanlaşmalarına yönelikti. Bu bağlamda TODAİE bünyesinde yapılan tezler yönettim ve ayrıca kurum çalışanlarının uzmanlık tezlerinin danışmanlığını üstlendim.

Bu deneyiminin yanı sıra 2005 yılından 2015 yılına kadar Sığınmacı ve Göçmenlerle Dayanışma Derneği’nin (SGDD) Yönetim Kurulu üyeliğini (2005-2009) ve Yönetim Kurulu Başkanlığını (2009-2015) yürüttüm. Bu zaman dilimi içerisinde bu alanda sahada birçok uluslararası projede yönetici ve *key expert* olarak çalıştım.
